Sir/Madam,

With reference to the subject cited above, this is to inform you that the College had submitted a proposal for Renewal of Continuation of Affiliation for the Academic Year 2026-27. Accordingly, the University appointed a Local Inspection Committee (LIC) vide the reference cited at Sr. No. 2 for inspection of the College and submission of its report.

The Local Inspection Committee visited the College and submitted its report to the University. The report was subsequently scrutinized and verified by the Board of Deans. Based on the recommendations of the Local Inspection Committee the Board of Deans submitted report to Academic Council. The Academic Council, approval is hereby granted for **Continuation of Affiliation / Natural Growth / Student Admissions**, as applicable, for the subjects and courses mentioned in the enclosed table for the Academic Year 2026-27.

Accordingly, the proposal for **Renewal of Continuation of Affiliation / Natural Growth** is approved under the provisions of **Section 114(1) of the Maharashtra Public University Act, 2016** for the Academic Year 2026-27.

The approval granted is valid **only for one academic year**, i.e., Academic Year 2026-27. Renewal of affiliation for subsequent academic years shall be mandatory and shall be subject to compliance with the provisions of the Maharashtra Public University Act, 2016, University Statutes, Ordinances and applicable regulatory requirements.

It is further informed that the institutions specifically notified as **"No Admission"** in the enclosed table are granted approval only for **Continuation of Affiliation / Natural Growth** for the Academic Year 2026-27. Such institutions shall not admit students to the First Year and Direct Second Year classes during the said academic year.

Any admission granted by a college contrary to the directions of the University shall be treated as unauthorized, and the entire responsibility arising therefrom shall rest solely with the concerned institution.

This approval is issued subject to the continuation of approval, recognition and fulfillment of norms prescribed by the **All India Council for Technical Education (AICTE) New Delhi / Pharmacy Council of India (PCI), New Delhi**, and other statutory regulatory authorities, wherever applicable.

Further, in cases where any matter relating to the institution is pending before any Court of Law, the approval granted herein shall remain subject to the final orders of the Hon'ble Court.

You are requested to take necessary action accordingly and ensure compliance with all applicable statutory and regulatory requirements
